

Ansgar Danish Lutheran Church ANNUAL GENERAL MEETING February 12th, 2017 at 12:00 pm Minutes

28 voting members were present

Call to order. Meeting was called to order at 12:10 pm by vice-president Brian Mogensen. The president recognized a quorum of voting members.

- **1. Opening hymn** no. 259 "Day by Day" and opening prayer by Pastor Lasse Hultberg.
- 2. Election of chairperson to the Annual General Meeting nominations from the floor. Alice Nickel was nominated by Dorrit Morrow. Alice Nickel accepted and was elected by acclamation.
- **3. Approval of agenda.** Marina Allemano noted that there was an error in item 5, "Business arising from the minutes of February 28, 2016": The meeting regarding bequests will be held on March 26, 2017, and not on March 24, 2017.

Motion: Birgit Wildenhoff moved to adopt the agenda. Jette Badre seconded. Motion was carried.

4. The minutes of the Annual General Meeting on February 28, 2016.

There were no questions or corrections. The minutes were for information only and accepted as presented.

- 5. Business arising from the Annual General Meeting on February 28, 2016.
 - a. Fund raising:

Ansgar Church Membership fee: a closed issue.

Bequests: Marilyn Withage, an investment manager with Raymond James, Calgary, will be speaking to the Congregation about the possibilities for making sound individual investment decisions in a will. The meeting will take place after the English service on March 26, 2017.

6. Reports presented in the printed AGM handout.

Danish Women's Club. The report was prepared by Jeanna Baty, and the financial statement was prepared by Bent Skousbøl.

Ansgar Men's Breakfast. The report was prepared by Kaj Nicolajsen.

Birthday Dollars. The report was prepared by Johanne Nicolajsen and audited by Kirsten Olsen. (Johanne Nicolajsen added that the "Birthday Dollars" are no longer deposited in its own designated account; however, she will continue collecting the "Birthday Dollars" and pass them on to the Church. Charitable tax receipts will be issued.)

Camp Kuriakos. The printed report from Camp Kuriakos to Congregational Annual Meetings in 2016 had been prepared by Rev. Art Weiss, Executive Director of Sylvan Lake Lutheran Bible Camp Association.

Hyggeklubben. The report was prepared by Randi Mark.

Coffee Fund. The report was prepared by Birgit Wildenhoff.

Marina Allemano noted that the Coffee Fund report was prepared by Birgit Wildenhoff; her name did not appear on the report.

Motion: Valerie Sørensen moved to accept the reports. Kirsten Thorup seconded. Motion was carried.

- **7. Pastor's Report**. The report for the year 2016 was accepted as prepared and presented by Pastor Lasse Hultberg. No questions arose.
- **8. President's Report**. The report for the year 2016 was accepted as prepared and presented by Kirsten Olsen. No questions arose.

9. Treasurer's Report.

The 'Statement of Receipts and Disbursements for the period January 1, 2016, to December 31, 2016,' and the statistical report for the same period were presented as prepared by Bent Skousbøl.

Bent Skousbøl explained the financial activities around the now completed elevator project. In order to finance the project, the Church Board obtained a line of credit with Ansgar Church's bank BMO. This step was taken to avoid cashing in the GIC investment which would have resulted in a considerable penalty. However, the line of credit was not put to use because an anonymous donation was given to Ansgar Church to cover all expenses associated with the elevator project.

The treasurer also pointed out that collections are not strong. A fundraising committee has been established to correct the revenue problem, as Ansgar Church cannot rely solely on large donations and bequests. New ways of dealing with collections and donations, e.g. preauthorized payments or online payments, will be explored.

Regarding the disbursements, Bent Skousbøl explained the increased GST expense and also mentioned that the insurance premium went down after the elevator was installed.

The statistical report 2016 shows that attendance is generally on the rise.

Questions from the floor:

- Johanne Nicolajsen asked under which heading the Birthday Dollars are placed in the Statement of Receipts and Disbursements. Bent Skousbøl replied that they are included with donations.
- Valerie Sørensen asked if the Treasurer could explain the details of the Enbridge Shares and their book value (\$41,351.35) listed in the Statement of Receipts and Disbursements. Bent Skousbøl explained that the shares were bequeathed to the Church, and that their book value goes up and down with the market. The Church Board has decided to keep the shares for the time being and sell them at a future date.

Motion: Brian Mogensen moved to accept the Treasurer's Report 2016. Edith Rasmussen seconded. The motion was carried.

10. Proposed Budget for January 1, 2017 - December 31, 2017.

The proposed budget was presented as prepared by Bent Skousbøl.

Question from the floor:

Niels Hansen inquired about the increase in program expenses. Bent Skousbøl clarified that \$5,000 have been set aside for the upcoming Kuriakos Camp, July 14-16, 2017, the reason being that the bequest of approx. \$40,000 (Enbridge shares) has been earmarked for youth programs by the bequeather. The Church Board has decided that the \$5,000 should be used for camp activites this summer.

Motion: Ellinor Gleerup moved to accept the Proposed Budget 2017, and Birgit Wildenhoff seconded. The motion was carried.

- Bruno Knudskov inquired whether the AGM Report booklet had been made available to the Congregation two weeks in advance of the meeting as he, regrettably, had not noticed it. Alice Nickel responded that the AGM Report booklet had been ready two and a half weeks before the meeting and had been placed in clear sight on the "Newsletter table" in the basement.
- Bruno Knudskov further suggested that the AGM Report be placed on the website and emailed out to the members two weeks in advance. Alice Nickel agreed that it would be a good idea to make the AGM Report available electronically in advance of the meeting; she forwarded the request to the new Church Board.
- Bruno Knudskov also asked if it would be possible to have Pastor Hultberg's sermons
 posted on the website which would help those members of the Congregation who are
 hearing impaired and who find it difficult to hear what is said on the pulpit. Alice Nickel
 replied that she would forward the request to the new Church Board.
- Bent Skousbøl mentioned that the Church needs to replace the organ, and that a new organ will exceed the amount (\$10,000) that the Church Board has the power to authorize for any one capital expenditure. Valerie Sørensen answered that an expenditure in excess of

- \$10,000 shall be authorized by Special Resolution of the Church, and that the Congregation must have at least fourteen days notice.
- Mette Rasmussen spoke to the question of fundraising and mentioned that United Way will
 donate to a church, and that the amount can be matched by a company.

Topics for the meetings varied:

Greg Mortensen's speech, Three Cups of Tea, DVD about how he meet and learned the culture and life in Afghanistan to promote equal life conditions there.

The Nielsen musical orchestra and choir sing-along.

The DVD, "Kongen bød", about the conditions that led up to the reformation of governing in Denmark and the constitution, (Grundloven).

Leif Gregersen's presentation on his bipolar disorder, how to live with it and mental problems in a broader scale.

A DVD about modern development on the small island of Læsø in Denmark, with an idea to become energy self sufficient to the point of trading power with the mainland.

A presentation about overcoming hearing disorders, how to go about getting a hearing aid and to improve facilities with system Loop and T-coil, an installation presently installed on a trial basis in our Church.

2017 in REVIEW:

Summer programs saw the addition of 3 Adventure Weeks, with overnight canoe trips, for kids and youth. This has provided an exciting alternative to our on-site programming, and has expanded the options for all age groups.

For our on-site programs, 2017 saw the creation of 4 new Camp-Out sites. Each week on Tuesday night, all our cabin groups participated in a Camp-Out, including supper and breakfast on the fire. Between this program and our new Archery Range, we have made more use of the soccer field property.

The last addition was a Day Camp program, offered in partnership with a congregation in Airdrie. We're looking forward to supporting congregational ministry through this new off-site program. Contact us to discuss hosting a program!

Our staff team has some new faces, with the hiring of Madi Alexandriuk as Hospitality Manager and Rudy Lange as Property Manager. A huge thank-you to Ken and Carol Bell, who have retired to Regina to spend time with their family, and to Anita Balogh, who has returned to school.

Sylvan Lake Lutheran Bible Camp Association had 9 Partner congregations and 10 Member congregations. The board of SLLBCA has begun consultations with Lutheran and Anglican congregations in Alberta (current and potential members). Board and staff members have attended council meetings at many congregations, and these partnerships continue to find ways for camp to be involved more directly in congregational life. Please contact us if you are interested in joining this discussion.

Many congregations continue to provide financial support as part of their annual budgets or through special gifts. Program revenue covers roughly 40% of the cost of hosting campers. This is a wonderful opportunity to bless kids and families in need, giving them the best week of their year. If your congregation is able to make a donation or finance a local Campership Fund, please contact the camp office.

Camp Use:

- Summer: Kuriakos served 564 campers for a total of 3137 days.
- Retreats: Including Youth (LOGOS), Dad+Kids, Women's, Advent, SHIFT, and Confirmation Retreats, we served 165 campers, for a total of 495 days.
- Kuriakos Outdoor School (KOS) programs: Serving 12 groups for a total of 441 students and 1222 camper days.
- Service events: 250 attendees at our fundraiser in April and 140 people participated in service projects at our Work Weekends and Work Weeks.
- Rentals: Kuriakos served 82 groups over 261 days of use. These groups represent 3261 individuals and 9490 camper days.

Pastor's Report to the Annual Meeting 2017

2017 was a fantastic year for Ansgar Lutheran Church. New life has floated into our little congregation in many ways, with a renewed hope that has given us new energy to work even harder for the growth of this beautiful, little Church.

Many of the initiatives in 2017 have successfully grown not only in quantity, in numbers of participants, but even more in quality, in the spiritual growth. The choir has grown in numbers of singer as well as in quality. We have been blessed by a steady commitment of the singers at rehearsals, Church Services, at the reformation celebration and especially at the Christmas Evening Song, December 8. Some of the singers have been singing for years and have lots of experience, others are beginners, trying out their voices and part singing for the first time, but everyone has done a great job and has been valuable to the ensemble. Well done to all the singers!

A highlight in 2017 was the Summer Church Camp at Kuriakos. After a few years without camp it seems as if Ansgar was ready for a weekend full of fun, fellowship and worship. 42 participated in the camp 2017, 19 of which were kids. The weather was perfect and the atmosphere even better! Everybody got along so well. I won't hesitate to say that we all had a wonderful time. Everybody helped each other, and we simply became one big family for the weekend. I feel this camp has helped us build up a solid foundation for this congregation, and I cannot wait to get back to camp again in 2018, to solidify the foundation of our Church fellowship.

Another highlight in 2017 was the Reformation Celebration. 500 years ago, October 31, 1517, Martin Luther publicized his criticism of the Catholic Church. This event led to the foundation of the Evangelical Lutheran Church, of which Ansgar is a part. On June 11, Trinity Sunday, we planted a combination apple tree west of the Church in the memory of Martin Luther and the Reformation. The tree has been grafted with 5 different apple varieties in the recognition of the different Church denominations - that we are all different branches in Christ, living and growing together. The study group has studied Martin Luther this year, and the choir has been singing some of his hymns. The Danish Women's Club organized a Morten's Aften, Saint Martin's Eve, Duck Dinner on the birthday of Martin Luther, November 10. Then we walked to Ansgar for another short service. We visited the Sacred Heart Catholic Church across from Ansgar and ended in Saint John Evangelical Lutheran Church for a short service and a wonderful lunch in the Church hall. Martin Luther's hymn "A Mighty Fortress is our God" was sung in Danish, Cantonese and German, and the choirs from Ansgar and Saint John sang two Luther hymns together. It was an awesome day!

There are so many other things to mention. Here just a few: the Julestue followed by Christmas Evening Song on December 8 was a success with more than 70 participants; the Family Badminton; the Soup Night; the Frikadelle Contest; the Spring Supper; the Christmas Bazaar and all different group activities in the Church. It has been a busy, but fantastic year!

But nothing would have been possible if not for you, the members of the congregation, participants in the Church activities and services, the board members, and all the hard working and committed volunteers. From my heart: a big thank you to all of you. The Church would be nothing without you as well as the hands, minds and souls of all those who feel at home in this wonderful Church. I feel the spirit and fellowship is growing in Ansgar, and I only have one petition with you for the new year, 2018: keep on with the good work and why not invite your friends, neighbours or family to join us at Ansgar! 2.3 ELECTION TO THE CHURCH BOARD OF DIRECTORS

2.2 Qualifications

A member shall be qualified to be on the Church Board of Directors if:

- a) That person is an active Member who has been a Member of the Church for at least six months
- b) that person is over the age of 18 years
- c) that person does not have a status of a bankrupt; and
- d) that person is mentally competent

2.3.1. Nominations

Persons possessing the qualifications set out in Article 2.2 can be nominated for election to the Church Board of Directors.

2.3.3. Additional Nominations

Nominations for candidates for a position on the Church Board of Directors can also be made from the floor at the Annual General Meeting by any active Member, providing that any candidate, so nominated, agrees to let his or her name stand for a position on the Church Board of Directors. These nominations can be made in addition to a slate of candidates made to the Nominations Committee.

2.3.4 Nomination and Election of the President

The President is elected by a simple majority vote, using ballot procedure. If the President is elected from the existing Church Board of Directors, another Member is elected to the Board as a substitute in this position for the one year he/she is President. If a substitute for the President is required, he who received the 4th highest number of votes is elected to that position.

2.3.5 Nomination of Remaining Board Members

In electing the other three Members, three names can be written on the ballot. The three who receive the most votes are elected.

2.4 TERM OF OFFICE

The President is elected for a one-year term at each Annual Congregational Meeting; the remaining nine Board Members are elected for a three-year term in such a manner that three are elected each year. The Pastor is a permanent Member of the Board.
